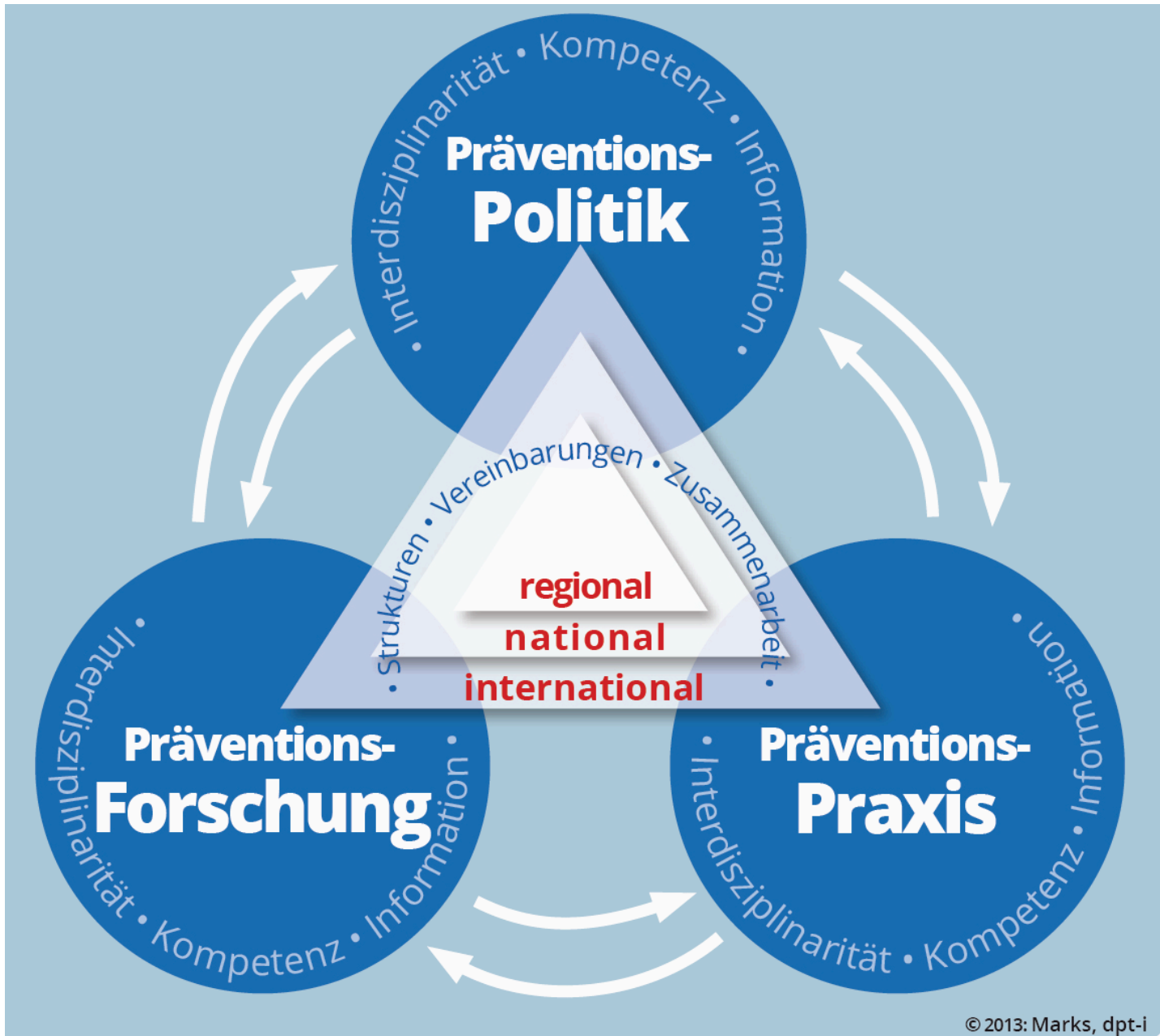
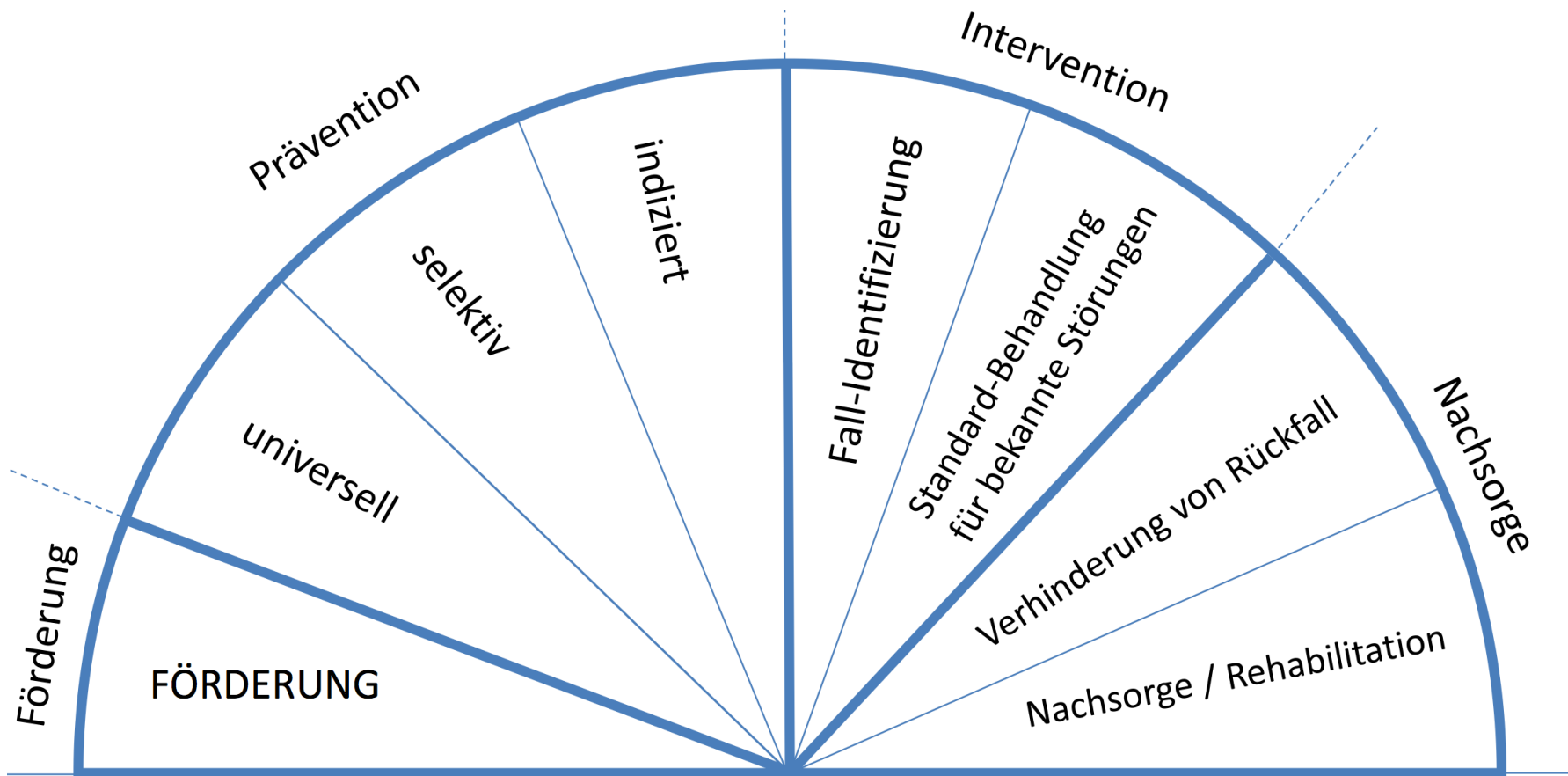

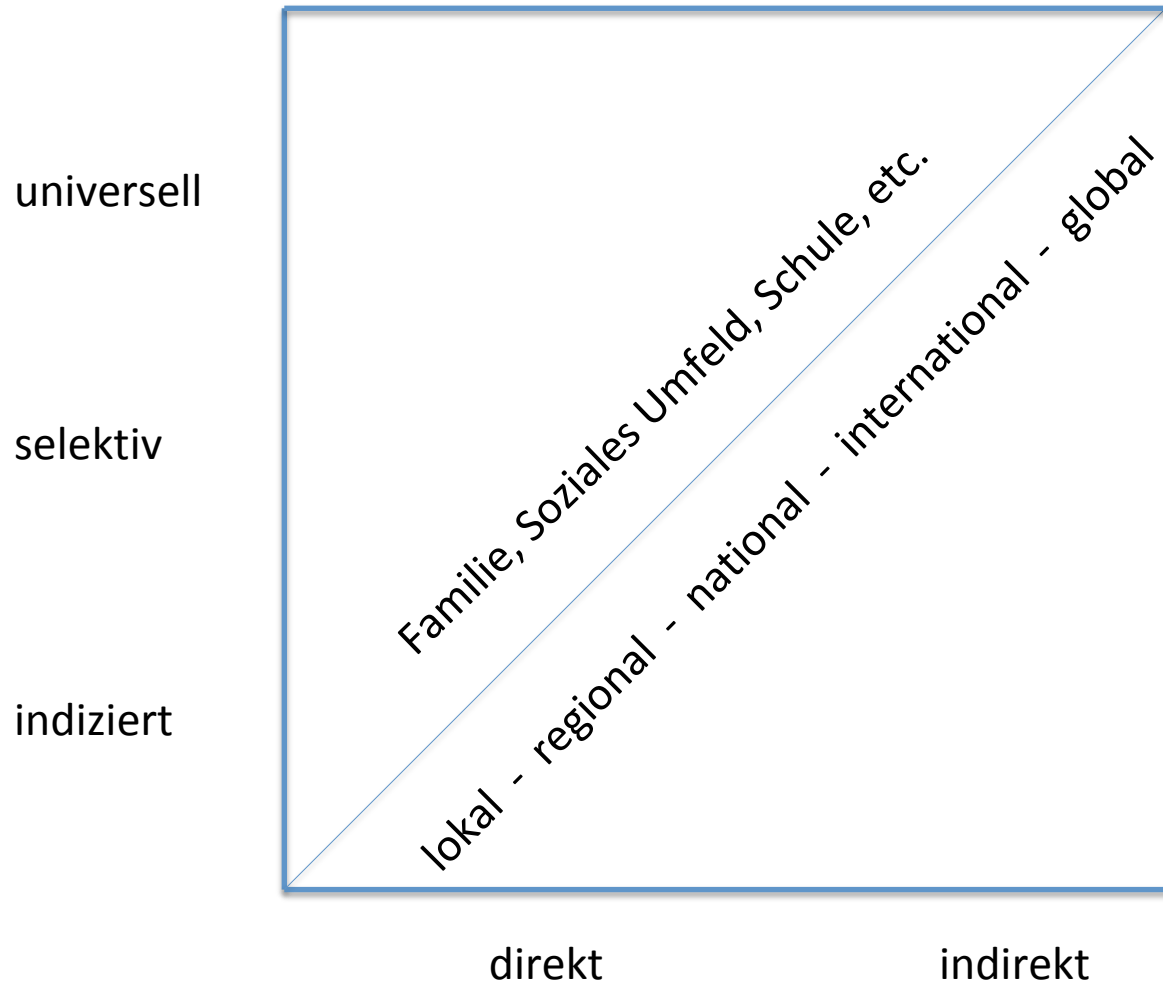




Einteilung des Präventions- / Interventionsspektrums nach IOM / NRC 2009

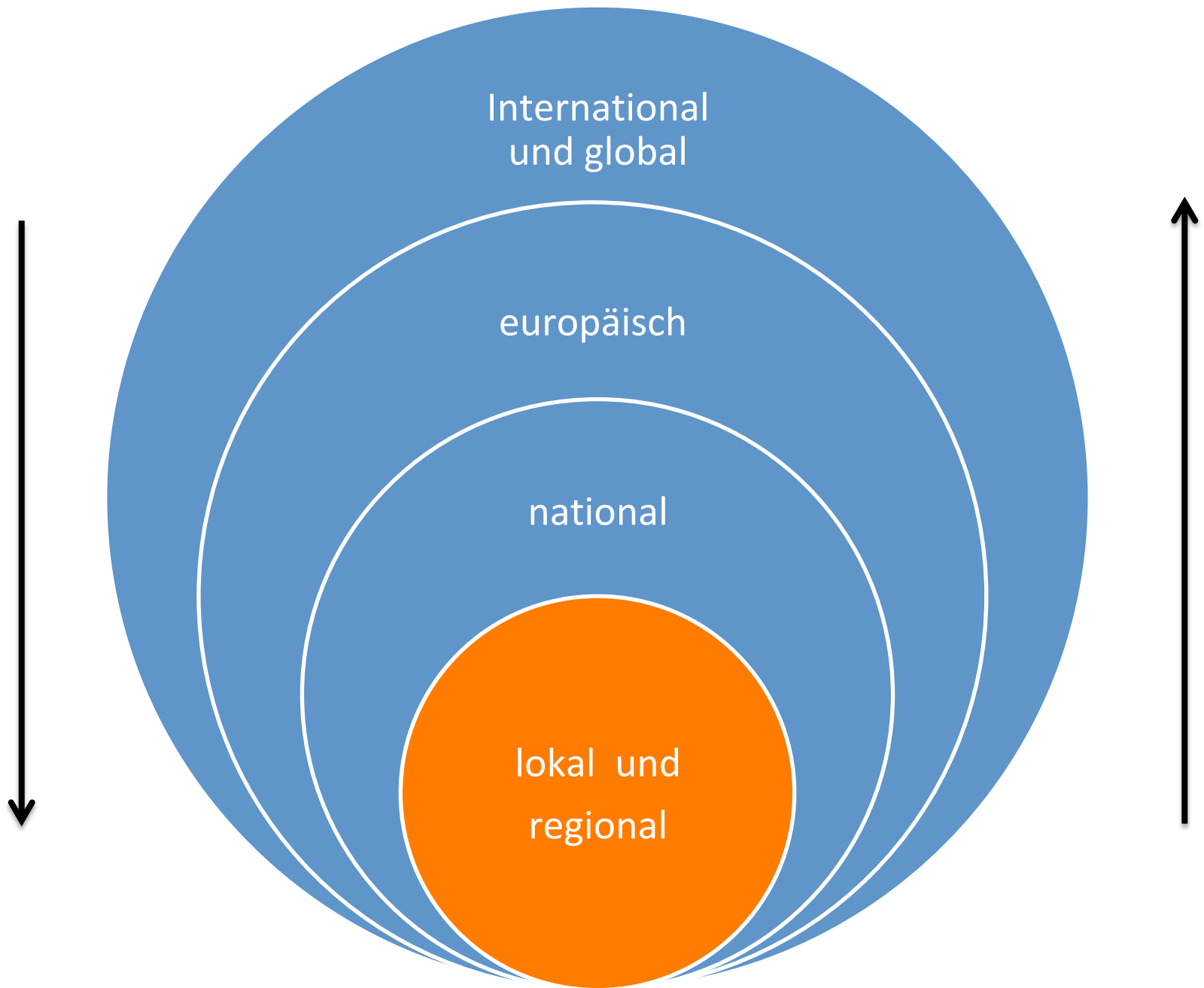
Kooperationen und Netzwerke

Eine gute Vernetzung auf kommunaler sowie auf Landesebene ist ein Merkmal der gesamtgesellschaftlichen Kriminalprävention in Niedersachsen. Der Landespräventionsrat Niedersachsen sucht gezielt die Kooperation und den Austausch mit allen Akteuren der Kriminalprävention. Kriminalprävention ist ein sich im nationalen und internationalen Kontext stetig entwickelndes Handlungsfeld. Dies betrifft sowohl Forschungsergebnisse als auch Umsetzungserfahrungen in der Praxis. Der LPR unterhält daher intensive Arbeitsbeziehungen und Kontakte zu zahlreichen Organisationen auf nationaler, europäischer und internationaler Ebene. Zur Koordination und Ausweitung dieser Kontakte wurden erstmals 2008 die Arbeitsgruppen „Nationale und internationale Netzwerke“ und „Kooperationen in Niedersachsen“ eingerichtet und 2015 zur Arbeitsgruppe „Kooperationen und Netzwerke“ zusammengeschlossen

Aufgaben der Arbeitsgruppe sind:

- Fachliche Begleitung aller Kooperationsprojekte des Landespräventionsrates
- Integration national und international gesammelter Anregungen und Erfahrungen („Import“)
- Information über Ziele und Projekte des LPR auf nationaler und internationaler Ebene („Export“)
- Koordination von Beteiligungen des LPR an Projekten und Programmen verschiedener nationaler und internationaler Partner
- Akquise von Drittmitteln auf nationaler und internationaler Ebene
- Erörterung projektübergreifender Fragestellungen und präventionsrelevanter aktueller Entwicklungen

Building an evidence-base for the prevention of radicalization and violent extremism International Conference - Hanover June 16-18, 2017

SUMMARY OF PANEL DISCUSSIONS

The prevention of radicalization and violent extremism ranks high on the international political agenda, but our understanding about the impact of preventive programs and measures is still limited.

To reduce the threat of terrorism and political violence effectively and through proven practices, policy makers and practitioners need a reliable evidence base. Rigorous evaluation is also crucial for political accountability as public spending grows together with concerns about the effectiveness of these programs. Consequently, we need to know whether the actions taken have the desired effect because it consumes precious times of various professional groups to implement and deliver preventive measures. We therefore need a better evidence base to see whether social interventions - may it be in school, in the community or in prison - are worth our efforts.

The conference takes place on June 16-18, 2017 at the Hannover Congress Centre - HCC (Germany). It will bring together selected researchers, practitioners and policy makers with the goal:

- To debate the virtues of "evidence-base practises" in the context of radicalisation and violent extremism.
- To discuss the right balance between necessary pragmatism and scientific rigor.

Updated Inventory of Evidence-Based, Research-Based, and Promising Practices: For Prevention and Intervention Services for Children and Juveniles in the Child Welfare, Juvenile Justice, and Mental Health Systems

EBPI & WSIPP**September 2017**

The 2012 Legislature passed E2SHB 2536 with the intention that “prevention and intervention services delivered to children and juveniles in the areas of mental health, child welfare, and juvenile justice be primarily evidence-based and research-based, and it is anticipated that such services will be provided in a manner that is culturally competent.”

The bill directs the Washington State Institute for Public Policy (WSIPP) and the University of Washington Evidence-Based Practice Institute (UW) to publish descriptive definitions and prepare an inventory of evidence-based, research-based, and promising practices and services, and to periodically update the inventory as more practices are identified. This is the seventh update to the September 30, 2012 publication. The accompanying report describes the inventory update process, as well as the ongoing technical assistance process by UW.

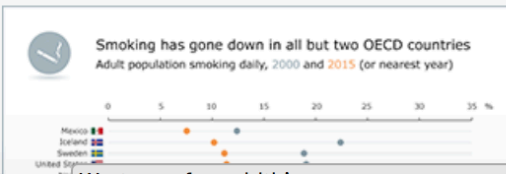

Crime Prevention and Criminal Justice

UNODC has the mission of making the world safer from crime, drugs, and terrorism. To be effective and sustainable, responses to these threats must include strategies covering the following areas:

- **Crime Prevention**, especially Urban crime prevention; Armed violence prevention; Preventing recidivism
- **Criminal Justice Reform**: Police reform, Prosecution service, Judiciary (the courts), Access to defence and legal aid, Prison reform and alternatives to imprisonment, and Restorative justice
- **Justice for children; Support and assistance to victims; Gender in the criminal justice system**

Crime prevention and criminal justice strategies must take a human rights approach and be based on the rule of law, together with the UN standards and norms in crime prevention and criminal justice.
